The Municipality of San Rafael, Bulacan, through its Bids and Awards Committee (BAC), invites bids for the:

Name of Project	: WATER SUPPLY SYSTEM
Brief Description	: Supply and Installation of Water Supply System with 2HP Jet WATER Pump, 42 gals Pressure Tank and 840L Storage Tank
Location	: MRF-Coral na Bato, San Rafael, Bulacan
Funding Source	: General Fund
Approved Budget for the Contract	: 699,232.76
Contract Completion Period	: Thirty (30) calendar days

Procurement will be conducted through open competitive procedures using non-discretionary “pass/fail” criterion as specified in the 2016 **Revised Implementing Rules and Regulations** of Republic Act 9184.

Bidding is restricted to Filipino Citizens/Sole Proprietorship, Cooperatives, (b) Filipino Citizen or 75% Filipino-owned partnership, corporation, cooperative or joint venture, and (c) Net financial contracting Capacity at least equal to ABC, or credit line commitment at least equal to 10% of ABC. The BAC will use non-discretionary pass/fail criteria in the eligibility check, preliminary examination of bids.

The BAC will issue copies of Bidding Documents (BD's) at Municipality of San Rafael – Maharlika Highway, Sampaloc, San Rafael, Bulacan. The cost of bidding documents shall correspond to the amount of ABC, as per GPPB Resolution No. 02-2014 dated February 24, 2012. Bids must be accompanied by a bid security, in the amount and acceptable form, as stated in section 27.2 of the Revised IRR.

Prospective bidders shall submit their duly accomplished forms as specified in the BDS in two (2) separate sealed bid envelopes to the BAC Chairman. The first envelope shall contain the technical component of the bid. The second envelope shall contain the financial component of the bid. Late bids shall not be accepted. Contract will be awarded to the Lowest Calculated Responsive Bid as determined in the bid evaluation and post – qualification.

The Municipality of San Rafael, Bulacan reserves the right to accept or reject any bid, and all bids, to annul the bidding process and declare failure of bidding any time prior to contract award in accordance with section 41 of RA 9184, without thereby incurring any liability to the affected bidder(s).
